

Notice of Opportunity to “Test Out” of Specific Courses

Public Act 335, Section 1279B of the State School Code requires the opportunity for any high school student to “test out” of any course. The “test out” option does not include those courses for which students are currently enrolled.

Students will need to exhibit mastery of the subject matter by attaining a grade not less than a 78% in a comprehensive exam. Each student may be required to demonstrate mastery through the basic assessment used in the course, which may consist of a portfolio, performance, paper, project, and/or a presentation.

Credit earned is to be based on a “pass” grade and will not be included in a computation of grade point average. Credit will be counted toward fulfillment of a requirement for a subject area course and will be counted toward fulfillment of a requirement as to course sequence. Students may not receive credit thereafter for a lower course in course sequence concerning the same subject area.

Dates of Testing:

Winter Testing will be December 9, 2019 at with a registration deadline of November 8, 2019
Summer Testing will be on March 12, 2020 with a registration deadline of February 20, 2020.

Please turn forms into the counseling office by the indicated deadlines to reserve your seat.

Time / Place/ Circumstances of Testing:

All testing will be completed at Lapeer High School. There will be three scheduled test sessions.

Session One (HS) 3:00 p.m. -- 5:00 p.m.

Session Two (HS) 5:15 p.m. – 7:15 p.m.

Unless the high school student elects to take two tests, he/she will test at 3:00pm.

Session Three (for R-W ONLY) 4:30p-6:30pm

Students may request information for each course for which they intend to “test out” from their counselor. The information will include a course description, a course syllabus, and a description of “test out” requirements.
